02. Bidding will be conducted through the National Competitive Bidding Method (Single Stage Single Envelope Bidding Procedure).
03. Eligible bidders interested in this regard may obtain further details from Chief Accountant, Ministry of Public Security and Parliamentary Affairs via TP No : 0112 887697 / email : [mops.procurementunit@gmail.com](mailto:mops.procurementunit@gmail.com) or can inspect the procurement document free of charge from **28.03.2025 to 24.04.2025 between 9.00 am to 3.00 pm** on weekdays excluding public and bank holidays at Finance Division, Ministry of Public Security and Parliamentary Affairs, 17<sup>th</sup> Floor, Suhurupaya, Battaramulla or through our official website ([www.pubsec.gov.lk](http://www.pubsec.gov.lk)).
04. All bidders who meet the eligibility requirements must have the legal right to supply the relevant goods. The bidder must have registered his organization as a business, and if the value of the bid submitted by you is more than Rs. 5 million, it should be registered under the Public Contract Act No. 3 of 1987. Failure to submit this registration certificate with the bid will be grounds for rejection of the bid. The name of the bidder should not appear in the government's blacklist. Additional details in this regard are provided in the Procurement Documents.
05. A set of Procurement documents prepared in English language can be obtained by the interested bidders by submitting a written application to the following address and paying a **non refundable fee of Fifteen Thousand Rupees (Rs. 15,000.00)** in cash from **28.03.2025 to 24.04.2025** on government working days from **9.00 am to 3.00 pm**. Only one bid form will be issued per bid per organization.
06. Bids should be sent in **duplicate** and can be deposited in the tender box kept at the **Finance Division of Ministry of Public Security and Parliamentary Affairs, 17<sup>th</sup> Floor, "Suhurupaya", Battaramulla** on or before **2.00 pm on 25.04.2025** or at the time of bid opening or can be sent via registered post to reach before the above deadline. The IFB number should be clearly marked on the top left corner of the envelope. Bids received late will be rejected. And the relevant bids will be opened on **25.04.2025 at 2.00 pm** at the Same address in the presence of the bidders or their representatives who wish to be present in person. The representatives of the participating bidders must bring a written consent of the bidder to open the bids. Any representative who fails to present the written consent of the bidder shall not be present at the opening of bids.
07. The validity period of bids submitted shall be from **25.04.2025 to 25.07.2025** (at least 91 days from the date of bid opening)
08. All bids must be accompanied by a bid guarantee of **Rs. 912,000.00 (Nine Hundred and Twelve Thousand Rupees)**, and the bond submitted must be under the following conditions.
- Issued by a Commercial Bank approved by the Central Bank which is operating in Sri Lanka.
  - The bid guarantee form shall be in the form contained in Section IV of the set of bid forms.
  - Bid guarantee should be addressed to Secretary, Ministry of Public Security and Parliamentary Affairs.
  - The validity period of bid guarantee shall be from **25.04.2025 to 22.08.2025** (At least 119 days from the date of bid opening)
09. A pre-bid meeting will be held on **09.04.2025 at 11.00 am** at the Ministry of Public Security and Parliamentary Affairs Auditorium.
10. The procurement committee can make the necessary amendments related to the monetary regulations and treasury instruction circulars that change from time to time during each procurement process, and the decision of the Ministry Procurement Committee should be considered as the final decision.
