



## Invitation for Bids (IFB)

### Purchase of Pairs of Sport Shoes to the Special Task Force of Sri Lanka Police PS/03/PB/PR/08/12/2023

01. Chairman, Ministry Procurement Committee, Ministry of Public Security, 14<sup>th</sup> Floor, "Suhurupaya", Sri Subhuthipura Road, Battaramulla invites sealed bids from eligible and qualified bidders to supply following goods.

02. Bidding will be conducted through the National Competitive Bidding Procedure.
03. Eligible bidders interested in this regard may obtain further details from Chief Accountant, 14<sup>th</sup> Floor, "Suhurupaya", Sri Subhuthipura Road, Battaramulla, and can inspect the bid documents free of charge from **23.06.2023 to 25.07.2023** between **9.00 am to 3.00 pm** on weekdays excluding public and bank holidays at Finance Division, Ministry of Public Security, 14<sup>th</sup> Floor, "Suhurupaya", Sri Subhuthipura Road, Battaramulla or through our official website ([www.pubsec.gov.lk](http://www.pubsec.gov.lk)).
04. All bidders who meet the eligibility requirements must have the legal right to supply the relevant goods. The bidder must have registered his organization as a business, and if the value of the bid submitted by you is more than **Rs. 5 million**, it should be registered under the Public Contract Act No. 3 of 1987. Failure to submit this registration certificate with the bid will be grounds for rejection of the bid. The name of the bidder should not appear in the government's blacklist. Additional details in this regard are provided in the Bidding Documents.
05. A set of bid documents prepared in English can be obtained by the interested bidders by submitting a written application to the following address and paying a non refundable fee of **Twelve Thousand Rupees (Rs.12,000.00)** in cash from **23.06.2023 to 25.07.2023** on government working days from **9.00 am to 3.00 pm**. Only one bid form will be issued per bid per organization.
06. Bids should be sent in duplicate and can be deposited in the tender box kept at the Finance Division of Ministry of Public Security, 14<sup>th</sup> Floor, "Suhurupaya", Sri Subhuthipura Road, Battaramulla on or before **2.00 pm** on **26.07.2023** or at the time of bid opening or can be sent via registered post to reach before the above deadline. The bid number should be clearly marked on the top left corner of the envelope. Bids received late will be rejected. And the relevant bids will be opened on **26.07.2023** at **2.00 pm** at the Ministry of Public Security Auditorium, 14<sup>th</sup> Floor, "Suhurupaya", Sri Subhuthipura Road, Battaramulla in the presence of the bidders or their representatives who wish to be present in person. The representatives of the participating bidders must bring a written consent of the bidder to open the bids. Any representative who fails to present the written consent of the bidder shall not be present at the opening of bids.
07. The validity period of bids submitted shall be from **26.07.2023 to 25.10.2023** (At least 91 days from the date of bid opening.)
08. All bids must be accompanied by a bid guarantee of **Seven Hundred Twenty Thousand Rupees (Rs. 720,000.00)** and the bond submitted must be under the following conditions.
- As a financial company, it should be a guarantee obtained from a registered institution of the Central Bank.
  - The bid guarantee form shall be in the form contained in Part IV of the set of bid forms.
  - bid guarantee should be in the name of Secretary, Ministry of Public Security.
  - The validity period of bid guarantee shall be from **26.07.2023 to 22.11.2023** (119 days from bid opening date)
09. Pre Bid Meeting will be held on **12.07.2023** at **2.00 pm** at the Auditorium, Ministry of Public Security, 14<sup>th</sup> Floor, "Suhurupaya", Sri Subhuthipura Road, Battaramulla, Sri Lanka.
10. The procurement committee can make the necessary amendments related to the monetary regulations and treasury instruction circulars that change from time to time during each procurement process, and the decision of the ministry procurement committee should be considered as the final decision.
