- 02. Bidding will be conducted through the **National Competitive Bidding** Procedure.
- 83 Eligible bidders interested in this regard may obtain further details from Accountant (Procurement), 14th Floor, "Suhurupaya", Sri Subhutipura Road, Battaramulla, and can inspect the bid dcouments free of charge from 21.09.2023 to 16.10.2023 between 9.00 am to 3.00 pm on weekdays excluding public and bank holidays at Finance Division, Ministry of Public Security, 14th Floor, "Suhurupaya", Sri Subhootipura Road, Battaramulla or through our official website (www.pubsec.gov.lk).
- 04 All bidders who meet the eligibility requirements must have the legal right to supply the relevant goods. The bidder must have registered his organization as a business, and if the value of the bid submitted by you is more than **Rs. 5 million**, it should be registered under the Public Contract Act No. 3 of 1987. Failure to submit this registration certificate with the bid will be grounds for rejection of the bid. The name of the bidder should not appear in the government's blacklist. Additional details in this regard are provided in the Bidding Documents.
- 05 A set of bid documents prepared in English language can be obtained by the interested bidders by submitting a written application to the following address and paying a non refundable fee of Fourteen Thousand Rupees (Rs.14,000.00) in cash from 21.09.2023 to 16.10.2023 on government working days from 9.00 am to 3.00 pm. Only one bid form will be issued per bid per organization.
- 06 Bids should be sent in duplicate and can be deposited in the tender box kept at the Finance Division of Ministry of Public Security, 14th Floor, "Suhurupaya", Sri Subhutipura Road, Battaramulla on or before 2.00 pm on 17.10.2023 or at the time of bid opening or can be sent via registered post to reach before the above deadline. The bid number should be clearly marked on the top left comer of the envelope. Bids received late will be rejected. And the relevant bids will be opened on 17.10.2023 at 2.00 pm at the Public Security Ministry Auditorium, 14th Floor, "Suhurupaya", Sri Subhutipura Road, Battaramulla in the presence of the bidders or their representatives who wish to be present in person. The representatives of the participating bidders must bring a written consent of the bidder to open the bids. Any representative who fails to present the written consent of the bidder shall not be present at the opening of bids.
- 07 The validity period of bids submitted shall be from **17.10.2023 to 16.01.2024** (at **least 91 days** from the date of bid opening)
- 08 All bids must be accompanied by a bid guarantee of Rs. 837,000.00 (Eight Hundered and Thirty Seven Thousand rupees), and the bond submitted must be under the following conditions.
 - As a financial company, it should be a guarantee obtained from a registered institution of the Central Bank.
 - ii. The bid guarantee form shall be in the form contained in Part IV of the set of bid forms.
 - iii. bid guarantee should be in the name of Secretary, Ministry of Public Security.
 - The validity period of bid guarantee shall be from 17.10.2023 to 13.02.2024 (At least 119 days from the date of bid opening)
- 09 A Pre Bid Meeting will be held on 04.10.2023 at 2.00 pm at the Auditorium, Ministry of Public Security, 14th Floor, "Suhurupaya", Sri Subhuthipura Road, Battaramulla, Sri Lanka.
- 10 The procurement committee can make the necessary amendments related to the monetary regulations and treasury instruction circulars that change from time to time during each procurement process, and the decision of the ministry procurement committee should be considered as the final decision.
