04. Discussed following matters

- i. Delivery dates of shoes to be extended up to 120 dates but **TEC not agreed to recommend.**
- ii. To be amended the specification as follows.
 - Lase loop position
 - Remove of cellhouse from Insole Material
 - Add out sole thickness 3.00 mm-4.00mm
 - Increase Heal Hight up to 30.0mm to 35.0mm
 - Add to dimension details of lase loop

Decision: The TEC lengthily discussed these pointed-out facts, and TEC finally recommend amending the specification in order to achieve the objectives of the procumbent. The directives were given to officers who attended the pre-bid meeting on behalf of the TEC member of SLSI to amend the specification with the concurrence of the TEC member and submit it to TEC again.

- iii. Due to these circumstances, representatives of the bidders requested that the tender opening date be extended by 3 weeks in order to prepare samples in accordance with the amendment specification

Decision: TEC recommended above request on the basics of the guild line of procumbent.
