## Invitation for Bids

### Construction of Buildings

01. The Chairman, Ministry Procurement Committee, Ministry of Public Security, 18<sup>th</sup> Floor, Suhurupaya, Battaramulla now invites for sealed bids from eligible and qualified bidders for the following Construction work;

02. Bidding will be conducted according to **National Competitive Bidding (NCB)** Procedure.
03. Eligible bidders interested in this regard may obtain further information from **Chief Accountant, Ministry of Public Security, 17<sup>th</sup> Floor, Suhurupaya, Battaramulla** and can inspect the bidding documents free of charge from **22.11.2024 to 13.12.2024 between 9.00 a.m. to 3.00 p.m. on weekdays** excluding Public & Bank Holidays at Finance Division, Ministry of Public Security, 17<sup>th</sup> Floor, Suhurupaya, Battaramulla or through our official website ([www.pubsec.gov.lk](http://www.pubsec.gov.lk)).
04. All bidders who meet the eligibility requirement must have the legal rights for the above constructions. The Bidder should be registered at the Construction Industry Development Authority (ICTAD/CIDA) under the relevant category indicated above and under Public Contract Act No. 03 of 1987. Failure to produce the registration certificates with bids will result in disqualification. Also the Bidder shall not be included in the list of debarred firms. Additional details are provided in the Bidding Documents.
05. A complete set of bidding documents in English Language may be purchased by interested bidders on submission of a written request with ICTAD or CIDA Registration to **Chief Accountant, Ministry of Public Security, 17<sup>th</sup> Floor, Suhurupaya, Battaramulla** upon payment of above mentioned non-refundable Bid Document Charge in cash from **9.00 a.m. to 3.00 p.m.** on weekdays excluding Public & Bank Holidays from **22.11.2024 to 13.12.2024**. Only a single set of bidding documents for each project shall be issued for an institution.
06. Bids in duplicate shall deposit in the tender box placed at the Chief Accountant, Ministry of Public Security, 17<sup>th</sup> Floor, Suhurupaya Battaramulla **on or before 10.00 a.m. on the date of opening of bids 16.12.2024**. Alternatively, bids may be sent by registered post to reach before the closing time of bids. The respective Tender Number should be indicated at the Top Left Corner of the Envelope. Any late bids will be rejected. Bids will be opened soon after closing of bids in the presence of the bidders or their representatives who choose to attend personally at the Finance Division, Ministry of Public Security, 17<sup>th</sup> Floor, Suhurupaya Battaramulla **on 16.12.2024 at 10.00 a.m.** The representatives who will attend to bid opening on behalf of the bidders should produce a written consent of the bidder. Any representative who fails to present the written consent of the bidder will not be allowed to participate in the bid opening event.
07. The validity period of the bid submitted shall be from **16.12.2024 to 17.03.2025** (at least 91 days from the date of bid opening).
08. All bids shall be accompanied by a **Bid Security of Five Hundred Seventy Thousand Rupees (Rs.570,000.00)** and it shall be under following conditions;
- Issued by any Commercial Institution operating in Sri Lanka and approved by the Central Bank of Sri Lanka or Construction Guarantee Fund. The bid security must be payable on demand and unconditional, and must be in the form specified in the bid documents.
  - The Bid Security shall be in the form contained in Section 09 of the Bidding Document.
  - The Bid Security shall be in favor of Security, Ministry of Public Security
  - Validity period of the Bid Security shall be from **16.12.2024 to 14.04.2025** (at least 119 days from the date of bid opening).
09. Bidders are expected to attend the Pre-Bid meeting which shall be held on **03.12.2024 at 11.00 a.m.** at the Special Task Force Camp, Training School, Upali Sahabandu Mawatha, Katukurunda, Kalutara after the site visit.
10. The decision taken by the Procurement Committee will be final and the Purchaser reserves the right to make any amendments based on Financial Regulations and Treasury Circulars issued time to time.
