2. Bidding will be conducted through National Competitive of Bidding (NCB) method and the source of funding is GOSL. (Single Stage one envelop Bidding Procedure)
3. Eligible bidders interested in this regard may obtain further details from Chief Financial Officer, Ministry of Public Security and Parliamentary Affairs via TP No: **0112 887396** / e-mail : **mops.procurementunit@gmail.com** or can inspect the bid documents free of charge, from **22.04.2026** to the date mention at the above table between **0900 hrs to 1500 hrs** on weekdays excluding Public and Bank Holidays at Finance Division, Ministry of Public Security and Parliamentary Affairs, 17th Floor, Suhurupaya, Battaramulla, Sri Lanka or through our official website (**www.pubsec.gov.lk**).
4. All bidders who meet the eligibility requirements must have legal right to supply the relevant Goods. The bidder must have registered his organization as a business, and if the value of the bid submitted by you is more than Rs.5 million it should be registered under the Public Contract Act No. 3 of 1987. Failure to submit this registration certificate with the bid will be grounds for rejection of the bid. The Bidder shall not have a conflict of interest and the name of the bidder should not appear in the Government's blacklist. Additional details in this regard are provided in the Procurement Documents.
5. A set of Procurement Documents prepared in English language can be obtained by the interested bidders by submitting a written application to the address and paying a non-refundable fee of as per above table in cash from **22.04.2026** to the date mention at the above table on Government working days from **0900 hrs to 1500 hrs**. Only one bid form will be issued per bid per organization.
6. **Separate bids must be submitted for the procurements mentioned in the table above.** Bids should be sent in duplicate (Original / Duplicate) and can be deposited in the tender box kept at the Finance Division of Ministry of Public Security and Parliamentary Affairs, 17th Floor, "Suhurupaya", Battaramulla **on or before the date and time specified in the above table** or can be sent via registered post to reach before the above deadline. The bid number should be clearly marked on the top left corner of the envelope. Bids received late will be rejected. Bids will be opened soon after the closing time in the presence of bidders or bidder's representatives. The representatives who will attend on behalf of the bidder should be definitely producing an authorized letter from the organization. Otherwise they will not be allowed for sitting.
7. The validity period of bids submitted shall be as per the above table.
8. All bids must be submitted with a bid security of the value and validity period specified in the table above, and the security submitted must be under the following conditions:
- Issued by a Commercial Bank approved by the Central Bank which is operation in Sri Lanka.
 - The bid guarantee form shall be in the form contained in Part IV of the set of bid forms.
 - Bid guarantee should be in the name of "Secretary, Ministry of Public Security and Parliamentary Affairs."
9. A Pre-Bid meeting will be held at the Ministry of Public Security and Parliamentary Affairs, 17th Floor, Suhurupaya, Battaramulla, Sri Lanka **on the date and time mentioned in the table above** for each procurement.
10. The procurement committee can make the necessary amendments related to the monetary regulations and treasury instruction circulars that change from time to time during each procurement process, and the decision of the ministry procurement committee should be considered as the final decision.
