All Bids shall be accompanied by a Bid Security of **LKR 15,650,000.00** valid till **26.02.2027** issued by **A local commercial bank** approved by Central Bank in Sri Lanka, which is Operating in Sri Lanka./ **A foreign commercial bank** operating in Sri Lanka, which approved by Central Bank of Sri Lanka.
7. In accordance with the Government Public Contracts Act No. 03 of 1987, the Tenderer, Agent, Sub-Agent, or any designated person acting on behalf of the Tender shall have duly completed the required registration.
